



## EUROPE and DISABILITY Project

### Fourth Newsletter

Europe and Disability Project that is carried out by Sinop Spastic Children Association (Turkey), CEIPES (Italy) and IPP (Romania) is very close to the end of the project period. Europe and Disability Project is performed within the scope of the “Turkey - EU Civil Society Dialogue” program carried out by the Directorate of EU Affairs under the EU Instrument for Pre-Accession Financial Assistance Program. Sinop Spastic Children Association (<https://www.sinopscd.org.tr/>) from Turkey is the coordinating institution of the Project. IPP (<http://cluj.institutphoenix.ro/>) from Romania and CEIPES (<https://ceipes.org/>) from Italy are co-applicants.

The project aims to raise awareness about policy and contribution of the European Union on disability and its support to people with disabilities at candidate countries and to increase the cooperation between the disability NGOs in Turkey and the disability NGOs in Europe,

Main activities that have been carried out for one year project duration are:

-Kick off meeting was held to increase the visibility of the project in Sinop on 29 June 2021.

-Qualitative and quantitative research was conducted to measure the view of the people with disabilities and people who has close links to people with disabilities about EU’s contribution on people with disabilities in Turkey.

-In addition, we produced 4 different reports on contribution of the European Union to the people with disabilities. These reports are:

-A network has been established that will promote cooperation between Turkish and European CSO's in the long run. We held on the first meeting of this network on March 2, 2022. Around 40 NGOs from Europe and Turkey attended the meeting.

-The final meeting of the project was held on 24.03.2022.
